# WALES TOWNSHIP REGULAR BOARD OF TRUSTEES MEETING APRIL 02, 2019

The meeting was called to order at 7:01p.m. and opened with the Invocation and Pledge of Allegiance.

- C. Approval of Financial Report (Treasurer) None. Financial report approved at 3-19-19 meeting.
- D. Approval of Additional Bills and Check Register (Clerk). Clerk read Check Registry and amount. Checks issued ran from #559 to #603; for a total of \$41,840.82.

**Motion** by Bobcean, second by Thomson, to approve Consent Agenda as presented. Roll call vote taken: Bobcean, aye; Thomson, aye; Messina, aye; Shannon, aye; Masters, aye. All ayes; motion carried.

QUESTIONS/COMMENTS from the audience on agenda items. None.

GUEST PRESENTATIONS: Sheriff Tim Donnellon, on Recreational Marijuana. Sheriff Donnellon gave a slide presentation on the recent legislation passed concerning recreational marijuana. Local municipalities must consider whether to allow commercial operations to exist in their jurisdictions or not. Some things to consider are; because marijuana is considered illegal by the federal government, banks cannot accept cash money from known operations. Therefore, robbery of their establishments is commonplace. Their guards are not allowed to carry weapons, for. He also went into the financial aspect of allowing such activities to exist. The State collects 10% of all taxes collected from them up front. No portion of that money is allocated to Law Enforcement. Local entities have three choices of action on the new laws. They can opt in, opt out, or wait to see if they want such establishments in their community. If you opt in, you cannot opt out later. That would put people in jeopardy who legally began a business. If you opt out, you can change your position later if you wish. Many of the local communities are choosing the "wait and see" attitude. Thomson asked if townships can pass moratoriums? No. Waddy asked if these regulations also pertain to commercial growers? Yes. Messina asked if the Federal government can shut things down? He doesn't know. It depends on who is in power in Washington.

- 3. Supervisor's Meeting. There was general discussion on the Drain Commission. Masters is working with St. Clair Township and Columbus Township concerning the Holland Drain, and the Drain Commission's plans for it.

Masters mentioned that cement pads will be necessary for the park benches. She will be meeting with Eric Shannon on the parks groundwork.
- D. Township Trustee (Planning Commission) (Thomson). Thomson thanked the Board for supplying the Planning Commission members with books and maps to work on the Zoning Ordinance review.
- E. Township Trustee (Zoning Board of Appeals) (Shannon). Shannon missed the last Fire Authority Meeting. There has not been a Parks meeting recently. Masters attended the Fire Authority meeting. Jeff White from RLEMS also attended. Draft submitted under Correspondence. Sheriff Donnellon was asked if the police work under such an act such as Act 57? No. She stated that Wales needs some firm financial figures. She explained some of the questions. Who owns the equipment? Who sets millage rates, etc.? Messina asked, "If the two fire departments want to keep their own equipment, what does the Authority have"? The next meeting is April 12th.
