Roll call vote taken: Bobcean, aye; Thomson, aye; Shannon, aye; Masters, aye. Four ayes; motion carried.

## Reports

- A. Township Supervisor (Masters)
- Cemetery Non-spendable Perpetual Care review. The restricted and non-restricted funds
  distribution has been questioned. It has been reviewed by the Treasurer and Auditor a few years
  ago. It may need to be placed in two separate accounts.
- B. Township Clerk's agenda (Bobcean).
  - The Audit has been completed, no problems.
  - 2. The election is August 06, 2019. Because of this, the next Board Meeting date is August 13.
  - 3. July birthday; Carly, July 4th.
- C. Township Treasurer (Messina) Township Parks Committee.
  - The savings Certificates were renewed for twelve months instead of six months because of the difference in interest rates. Parks reports that Shannon Excavating will start their work soon, with the construction people to follow immediately. Parks meeting schedules are to be set on confirmed dates, not "as we can". Bobcean and Masters both stressed having meetings.
- D. Township Trustee Planning Commission (Thomson)
   Thomson has invited Zoning Administrator Waddy to attend the next Planning Commission meeting on July 16.
- E. Township Trustee ZBA; SCC Parks: Fire Authority representative. (Shannon)
  The two fire departments involved seem intent on forming an Authority, with or without the involved townships joining. Motion by Thomson, second by Masters, to remove Wales Township from the Fire Authority meetings. Discussion followed. Masters is concerned with the possibility of monetary repercussions if we withdraw. Messina is concerned about service. She asked if the two fire departments can refuse us service? Also, can we refuse them? Neither side has any other choices than to continue service. Roll call vote was taken. Thomson, pass; Masters, yes; Shannon, yes; Messina, no; Bobcean, no; Thomson, yes. Three ayes; two nays; motion carried. Masters asked if anyone would object if she sent a letter to the departments and communities involved, requesting them to come to our Township for some answers and explanations. No objections were voiced. She explained the inequality with representation.

Old Business. None.

## New Business.

- A. Eugene Haley Board of Review resignation acceptance. **Motion** by Masters, second by Thomson, to accept Mr. Haley's resignation. All ayes; motion carried.
- B. Parkland 2019-2020 farm lease donation. Masters would like to have the money from the farmer's parkland "donation" to be put toward next year's account, since he can't farm this year due to the weather conditions. .Motion by Bobcean, second by Thomson, that we refund the donated money from the farmer in lieu of his inability to use the land. After discussion, Bobcean said she would like to withdraw her motion. Thomson concurred with her decision, and withdrew his second. Motion withdrawn.

C. Request for Resolution. Masters presented a Resolution in support of the efforts to stop the sale of Silver Trails Scout Camp. She explained the workings of the Conservancy in their efforts toward holding the land until Grant Township can obtain a grant to keep the land. It cannot be saved as a Scout Camp, but the township would like to preserve it as a park. No money comes from Wales if this Resolution passes. Motion by Thomson, second by Messina, to pass Resolution 2019-12. Bobcean said a Resolution is not necessary to show support, just a written letter. Others said a Resolution carries more weight. MTA is involved in this issue because of zoning issues involved. The County has agreed to help the (Grant) Township fill out grant application forms. Roll call vote was taken: Thomson, yes; Messina, yes; Shannon, yes; Bobcean, no; Masters, yes. Four ayes; one nay; motion carried.

Public Comments. When are the tax bills coming out? They went into the mail yesterday or today.

Adjournment. **Motion** by Shannon, second by Thomson, to adjourn. All ayes, meeting adjourned at 8:15 p.m. Next meeting date is August 13, 2019, at 7:00 p.m.
