 - 1. SCC Road Commission/Twp. Annual Meeting. We were reminded that the renewal of the SCC road millage is coming soon.

 - 3. St. Clair Co. Landfill Biomass Energy. The County leases the biomass energy system to DTE, says it's working very well, and unique, and profitable. Just after that, they raised their tipping fees.
 - 4. Kimball Twp. Treasurer George Jackson proposal. He said Kimball is proposing to offer Wales their fire protection coverage for \$30,000 a year to cover 12 square miles of Wales Township. This was an unsolicited comment from him.

- B. Annual Township gravel haul request. Wales Township received a \$10,000.00 grant from the Road Commission for our roads. The proposed road budget for the 2020-2021 year is \$100,956.24. Kimmen inquired about chloride practices, and had them explained. Motion by Thomson, second by Kimmen, to accept recommendations as presented. Roll call vote taken: Thomson, aye; Kimmen, aye; Messina, aye; Bobcean, aye; Masters, aye. All ayes; motion carried. There was discussion on the SSCRC report of Match Money carryovers.

- D. Lobby closure. A statement was submitted by the Office Staff, Deputy Clerk Waddy and Deputy Treasure Mikolajczyk asking about closing or keeping the Hall open during the pandemic. They would prefer to keep working on a restricted basis, if the Board agrees. The Board agreed with their letter, and approved of limited access of the public, but to continue regular hours if possible. Motion by Masters, second by Thomson, to approve their suggestions. RESOLUTION 2020-02 GENERAL APPROPRIATIONS ACT WALES TOWNSHIP

The Board of Trustees of Wales Township resolves:

Section 1: Title

This resolution shall be known as the Wales Township General Appropriations Act.

Section 2: Public Hearing on the Budget

Pursuant to MCLA 141.412: MCLA 141.412, a public hearing on the proposed budget was held on March 17, 2020. Published on March 12, 2020 in the Voice newspaper.

Section 3: Estimated Revenues

Estimated Wales Township General Fund Revenues for fiscal year 2019-2020 including an allocated millage of 0.68130 operating mills, 0.58050 fire mills and various miscellaneous revenues shall total \$604,446.00

Section 4: Mileage Levy

The Wales Township Board shall cause to be levied and collected the general property tax on all real and personal property within the township upon the current tax roll an amount equal to one mill as authorized under state law and approved by the electorate.

Section 5: Estimated Expenditures

Estimated Wales Township General Fund expenditures for fiscal year 2020-2021 for the various township activities are as follows: \$ 604,446.00.

Section 6: Adoption by Budget of Reference

The Wales Township General Fund Budget is hereby adopted by reference, with revenues and activity expenditures as indicated in Section 3 and 5 of this act.

Nancy Dudek, and Jane Maley, alternate a 1 day (8hr.) per week "temporary" position. Each work an 8 hr. day, every other week. The Board's action was to extend the "temp" position term, until the office caught up on our filing in multiple departments, while learning the "ins and outs" of our daily work flow. They've been working for our office since September, 2017.

Their contribution is justified and realized necessary now, as well as in intended case of an unavoidable absence of as Deputy Clerk or Deputy Treasurer. I feel there is a responsibility to recognize that we have not illuminated their utilization because of the realized need for them. They've both proven very useful, professional, & punctual.

I propose to the board, that we move to adopt an employee position of "Clerical Aid", paying \$15.00/hr., 8 hours per week, with Deferred Compensation benefit as with all other employees. "Clerical Aid" assists the needs of the officers and staff; learning different tasks in order to be most helpful in case of an absence. In times of an extended unavoidable medical leave of a Deputy Clerk or Deputy Treasurer, the "Clerical Aid" will work the weekly hours of the absentee. The hiring shall be a decision of the Board, while the Clerk, Treasurer, and Supervisor shall collectively be responsible for suggestions of the applicants and their performance. Rate of Pay adjustments will be determined by vote of the Township Board. As demonstrated successfully since 2017, this position's duties hours may be shared between two individuals.
