- B. Office Staff compliment. A letter was received from a contractor working in the Township, complimenting the Wales office staff for their courtesy and competency.

- A. Township Supervisor (Masters).
  - 1. FOIA requests. The office has received two FOIA requests from Black Knight, a real estate company, requesting the entire assessing information. That is an enormous amount of work, and the law says the township cannot charge more than \$400.00 for one request. Today an identical FOIA request came in from SEMCOG.
  - Resurface Cove Road from Marquette Road to Lambs Road. We have received an informal
    petition from residents of Lambs and surrounding area requesting the repaving of Cove and
    Lambs roads. Resurfacing Cove Rd. is estimated at \$100,000.00. Masters would like to
    apply for a Local Road Funding Grant.
- B. Township Clerk's agenda. (Bobcean) Clerk absent, no report presented.
- C. Township Treasurer's agenda. (Messina) Tax money collection is in full swing.
- D. Township Trustee-Planning Commission; Emergency Preparedness. (Thomson) A report was given on the Planning Commission workshop on the Solar Ordinance and the Master Plan review. Motion was made by Thomson, seconded by Masters, to write a letter commending the Office Staff members who were mentioned in the letter from Correspondence, (above) and include the Board members and the Deputy Supervisor in the list. Motion called: four ayes, one absent; motion carried.
