Minor also asked for the Recording Secretary to attach a note to the Board, with the Planning Commission asking to have the draft plan sent to the Planner for review.

Minor brought up the Recreational Committee on the 17<sup>th</sup>, and **moved** for a formal meeting between the Planning Commission and the Recreational committee to review the Recreation Plan. All ayes; motion carried.
